# PRESIDENT'S MESSAGE

# Oro Loma Wins SHELL Award for Excellent Risk Management Practices

Oro Loma Sanitary District was awarded the 2013 California Sanitation Risk Management Authority's Safety, Health, Environmental, Liability, and Loss (SHELL) Award in August 2013. The award recognizes the top agency among the 43 water/ wastewater agencies participating in the self insurance cooperative—recognizing excellence in risk management categories that include safety, employee health, environmental practices, employment practices, and general liability.

The primary goal of the award is to encourage proactive risk control, as opposed to reactive methods. Historically, risk control involved studying losses and how to prevent them. Best practices today involve the collection and assessment of forwardlooking indicators. Examples of such indicators include surveys of employee attitudes toward safety, anonymous inquiries to determine if employees know how to do their jobs safely, encouraging the reporting of mistakes, and conducting regular audits of existing procedures to identify "drift" away from the standard. As an example, if employees report that they perform work they do not know how to safely perform, an organization may be a prime candidate for a loss.

On the liability and environmental protection



categories, the District has implemented best practices to train on emergency response, and discuss potential hazards when performing complex or infrequent tasks. This year during a pump station bypass exercise, the discharge hose ruptured. If the hose had failed in a real event, the result could have been a sewage spill into the environment. These types of proactive testing and drills are what the SHELL award encourages and recognizes.

At the awards ceremony, the award judges asked how long it took to fill out the 17 page award application; General Manager Warner replied that it took three years. He went on to explain that three years ago, District staff used the application to audit its practices and identify areas for improvement. Over the two following years, staff implemented new policies, procedures,

# How to Protect Your Home from Raw Sewage

Oro Loma works very hard to maintain its record of having one of the lowest sewage overflow rates in California. But it is impossible to eliminate all the variables that can cause an overflow.

A backflow protection system installed on your lateral—the pipe that connects your home plumbing to the sewer main-will prevent sewage from backing up into your home from a blockage or overflow in the sewer main. The system redirects the sewage to your vard, rather than allowing it to come up through drains inside your home. The system consists of an extendable backwater check valve, the overflow device, and a two-way clean-out. The backwater check valve has a one-

way valve that allows wastewater to flow in only one direction-away from your house. Note: The backflow protection system will

only keep sewage from the street's sewer main out of your home. It will not help if your lateral is clogged between your house drain and the device.

An overflow prevention system has been approved for use in Oro Loma. Though there is no permit fee for installing the system, we recommend installation by a licensed plumber. Keep the system clear of obstructions, such as dirt or vegetation, which might interfere with its operation.

### **Tips for Trouble-Free Plumbing**

Whatever goes down the drain in your home enters a system of sewer pipes and pumps before reaching the Oro Loma wastewater treatment facility. From there, treated wastewater is discharged into San Francisco Bay. Along the way, pipes and pumps can be clogged by grease, wipes, and other items. Although Oro Loma maintains a state-of-the-art treatment facility, no facility is able to remove all traces of chemicals and other pollutants from household products that go down the drain.

Follow these tips to prevent clogs, avoid costly repairs, and help protect the environment.

#### KITCHEN

- 1. Manually wipe grease and fatty foods from pans and dishes before washing.
- 2. Pour cooled grease and cooking oil into a disposable container, store it in the freezer to harden, then dispose of it in the trash.
- Never allow these to go down the drain or garbage disposal: grease; greasy/fatty foods; fat, lard, shortening; meat drippings; frying oil; salad oil; butter, margarine; dairy products; soups and sauces; coffee grounds; produce stickers; meat; egg shells; bones; nuts.
- Collect food scraps in your small green pail or in a cardboard milk or takeout container, then transfer the scraps to your green waste cart.

#### BATHROOM

- Flush ONLY human waste and toilet paper. Put these in the trash, never in the toilet: disposable wipes; feminine hygiene products; condoms; paper towels; disposable diapers; cat waste and litter; cigarette butts; dental floss; cotton swabs; hair.
- 2. Prevent hair and pet fur from going down drains.
- Never flush or pour unwanted medications down a drain. For a directory of free pharmaceutical collection sites, visit http://www. nodrugsdownthedrain.org/NoDrugs/ and enter your zip code.

#### ALL DRAINS

Never pour chemicals, solvents, pesticides, paint products, or other forms of Household Hazardous Waste down any drain, inside or outside the house. Do not put them in the trash. Bring them to the Household Hazardous Waste Collection Facility for safe disposal. For more information, call (800) 606-6606.

#### DON'T FLUSH SO-CALLED "FLUSHABLE" WIPES!

Never flush disposable cleaning/disinfecting wipes, moist towelettes, or personal hygiene wipes—even if they are labeled as "flushable." These wipes do not break down in water and they can clog District sewer lines, lift station pumps, and wastewater treatment equipment.

# **NEW BENCHMARKING SERVICE FROM STOPWASTE**

Stopwaste, Alameda County's waste management authority, is introducing a new benchmarking fee and service. Stopwaste will study what is being thrown away as trash, and identify how much of that trash could be recycled or composted. A report will be prepared showing the results for a given service area, and mailed to all residents within the county. The report summarizes the findings of the study, and provides suggestions on how to decrease trash levels. Stopwaste is charging an annual fee of \$1.81 per residential account with one cart of trash service per week.

#### **OPT OUT OF BENCHMARKING FEE**

After receiving the first benchmarking service report (scheduled for January 2014), residents will have a 60-day window to opt out of paying the fee and receiving the report. To opt out, visit <u>www.StopWaste.Org/benchmark</u> or email <u>benchmark@stopwaste.org</u> within 60 days of receiving the first benchmarking report. Residents who do not opt out within this time frame will continue paying the benchmarking fee and receiving reports as long as they reside in Alameda County.

and standard practices. After those three years, the District was ready to apply.

Winning the SHELL award was a strategic goal established by the Oro Loma Board of Directors in our 10-year plan. The Board recognized the award's focus and value of proactive risk control across all phases of the District's operation. After the win, staff requested and obtained the applications from the competitors. This year, staff will audit the best practices in the state and select those to incorporate into our practices. It is another way the District works to maximize the public's investment in its infrastructure and protect the environment.
