

Recycling in Oro Loma is easy! You just need to know the **RIGHT** way to do it.

Here are some things you need to know:

- Recycling carts are emptied every other week. Check your recycling schedule to find your week.
- You can get a bigger recycling cart or even an additional one for free by calling Waste Management at (510) 613-8710.
- 3. Recycle old cell phones and batteries by placing them in separate zipped plastic bags and putting the bags ON TOP of the recycling cart.
- 4. Green waste carts are emptied every week.
- 5. Food scraps and food-soiled paper go into the green waste cart along with vard waste.
- 6. Up to two gallons of used motor oil and used motor oil filters can be recycled every week by putting them into special containers and setting them out next to the garbage cart. Call (510) 613-8710 for your free motor oil recycling jugs.

Supervisor Miley Awards District for Its Safe Drug Disposal Partnership

Prescription and over-the-counter medications are an important part of our lives. But how do you get rid of prescriptions that have expired or were never taken?

Flushing medications down the toilet or putting them in the trash can cause serious environmental harm. Sewage treatment systems are not specifically engineered to remove pharmaceuticals, and those drugs can pass intact into waterways. Pharmaceuticals disposed of in the trash end up in landfills where they pose a threat to underlying groundwater. Traces of popular heart medications, anti-depressants, antibiotics, cholesterol-lowering drugs, chemotherapy drugs, veterinary drugs, and hormones are turning up in San Francisco Bay.

The best way to limit the amount of these potentially hazardous drugs in our water is to bring unwanted prescription and over-the-counter drugs to a Household Hazardous Waste site in Oakland, Hayward, or Livermore, or to a community collection location. Be sure to remove your name and identifying information from all medicine labels. Controlled substances are not accepted.
